## So, Why the Pipes?

The tradition of the Pipes being played at Police or Fire Department Funerals in the United States dates back over 150 years. When the Irish and Scottish immigrated to this country, many of their traditions followed. One of the traditions was the playing of the Pipes and Drums, often played at Celtic Weddings, Funerals and Ceilis (dances).

Massive immigration to the east coast of the United States occurred during the great potato famine. Along with this, the pipes began to take hold in the Fire Service.

In the 1800's, Irish immigrants faced massive discrimination. Factories and the shops bore signs reading "**NINA**" **No Irish Need Apply**. The only jobs they could get were ones not wanted by anyone else. Jobs that were dirty, dangerous or both—Firefighting and Law Enforcement. It was not an uncommon event during this time to have several Firefighters killed at a working fire and the Irish Firefighter's Funerals were typical of all Irish Funerals—with the Pipes being played. It was deemed acceptable for a hardened Police Officer or Firefighter to cry at the sound of the Pipes when his dignity would not let him weep for a fallen comrade.

Anyone who has attended a funeral in which the Pipes were played is familiar with the mourning and haunting sound of the Pipes. Before too long, families and friends of non-Irish Firefighters began to ask for a Piper to play for these Fallen Heroes. The Pipes added a special air to the solemn occasion.

## *The Story of Desmond's March*

On July 3<sup>rd</sup> 2018, the Camden County Emerald Society Pipes and Drums played an Independence Day parade in Maple Shade, NJ. After the parade, a few of us enjoyed a few beers, as is customary. I was talking with our Drum Major, Richard Desmond (AKA Desi). He had a sadness in his eyes and his voice was nostalgic when he spoke. He told me that he knew that his marching days were numbered. He said that he would love for the band to write an original tune and he wanted to call it "Emerald's 10." Desi is the founding member of the Camden County Emerald Society and the Camden County Emerald Society Pipes and Drums, which is the 10<sup>th</sup> Chapter in NJ. He said that he would love to call the tune "Emerald's 10" on the street, before he could no longer march.

The look in his eyes and the tone of his voice, made an everlasting impression on me. This man, who meant the world to me, made a modest request and I intended to honor it. The next day I sat down with a chanter, and I was determined to write the tune. I had a melody in my head, and I let my fingers go. I was so inspired that I wrote the tune in 24 hours. However, I wasn't feeling the name Emerald's 10. This was my first attempt at writing an original tune and, selfishly, I wanted the tune to have more meaning to me. At that time, I decided that I wanted to name the tune after the man responsible for creating this brotherhood. Richard Desmond is the reason why I joined this band. I saw him lead this band during Tommy Stewart's repast and during my police academy graduation. Desi's command presence and booming voice left an indelible impression on me. I had chills running down my spine and the hairs on my neck stood straight. Both experiences stirred something inside me and made me say to myself, "I'm going to do that one day!" He's the founding father of this band, my mentor, and my brother. This was my chance to express my gratitude to him. The name of the tune would be Desmond's March.

I originally planned on unveiling the meaning of the tune at our 2019 St. Patrick's Party. In order to do this, and keep it a surprise, I had to come up with a cover name for the tune. In true CCESPD fashion, I wanted to find a satirical name that would bust the chops of Desi. I researched Irish Literary Characters and came across The Muldoons of Lurg. Here is the origin of the Muldoons of Lurg:

Writing of the (O) Muldoons of Lurg in his *The Fermanagh Story*, Peadar Livingstone quotes John O Donovan (1809-61), antiquary and scholar, as recording that "a dozen of the warlike men of Lurg would beat a funeral of the men of any other barony. They are ***tall and stout with large heads and round faces***".

I read the physical description of the Muldoons, chuckled, and pictured our very own Richard Desmond. I let the board members and pipe officers in on the secret. The idea was to surprise Desi and the whole band at the party, but as fate would have it, the plans were changed.

In 2016, the band went to Ireland for St. Patrick's Day. On St. Patrick's Day, I was in Molloy's Pub in Tallaght Ireland. While heading to the restroom, a friendly guy named Tim Farelly asked me what band I belonged to. We struck up a conversation, and he told me that he played with St. Laurence O'Toole Pipe Band. If you don't know, St. Laurence O'Toole Pipe Band is World Class Grade 1 Pipe Band, and I was star struck. We had a very pleasant conversation and I went back to my table. A short while later, Tim returned to my table and laid down a St. Laurence O'Toole Pipe Band bagpipe cover. It was their 100<sup>th</sup> anniversary bagpipe cover and it was the year that they won the Grade 1 World Pipe Band Championships. He presented the bag cover to me as a gift. I was in shock and told him that I couldn't accept such a gift. He insisted, and I was left in awe; so much so, that I didn't even get his name! I eventually was able to learn of Tim's name.

In September of 2018, members of the band went to Ireland for John (AKA Chilly) McQuillan's wedding. I presented Tim with our new bag cover with our 20th anniversary patch sewn on. Tim was thrilled and said he would proudly display it on his concert pitch bagpipes. Tim mentioned that he was going to be playing the Uilleann Bagpipes, during a traditional music session, at the An Poitin Stil pub that night. Of course we wanted to watch a good traditional session, and we decided to go. Tim invited me to sit in on the session with my practice chanter. At one point, he asked me to play a tune. There was something in the atmosphere of the pub, the sound of the traditional music, and of course the Guinness was superb. All of a sudden, I had the overwhelming urge to unveil Desmond's March to Desi.

As fate would have it, Desi would not live to see the 2019 St. Patrick's Day Party, which was the originally scheduled unveiling of the tune. The day after I unveiled the tune, I was upset with myself. I pictured the surprise unveiling of Desmond's March in my mind, and it was amazing. If I waited to unveil the tune at the 2019 St. Patrick's Day Party, it would've been in front of 600 people, and several of our band members would've been shocked by the surprise. I felt like I let the band down. After Desi's passing, several band members expressed that they were, in fact, initially disappointed that I didn't stick to the original plan. We were all ultimately relieved that I didn't stick with the plan.

It was fate that made me unveil that tune. If it weren't for the generosity and kindness of Tim Farelly, we would have never been to the An Poitin Stil Pub that night. Tim would not have asked me to play a tune, and I would not have had the overwhelming urge to unveil the tune to Desi that night. I thank God that fate took the wheel in that Rathcoole Pub!

Desi's reaction in that quaint portion of the pub was more than I ever dreamed of. He was moved to tears, snapped a smart salute, gave me the biggest hug, and we told each other that we love one another.

Here was Desi's response on Facebook: "Tonight we left Molloy's in Tallaght to see a friend of ours who was playing in a session at The Poitcheen Jug down the road. About 30 minutes later the musicians called me up to the stage... and I'm thinking they wanted me to sing an Irish tune. Instead, Pipe Major Jason Flood introduced me to the crowd and announced he had written a tune in my honor. With that he began to play "Desmond's March". Well I completely lost it. It was then that I found out the band has been rehearsing this tune since last Memorial Day. Knowing that the men on vacation with me were in on this took me apart. I found out it was to have its debut at our 2019 St. Patrick's Day party...but Jason & the boys decided to play it here in Ireland. I am forever humbled and honored that Jason took the time to write this beautiful tune. To my band mates...I love you all and I'm forever grateful for your friendship & dedication to duty. It's truly an amazing feeling to know that your friends think enough of you to compose a tune in your honor. I don't mind saying I lost it but this is a once in a lifetime event. Thank you Jason & thank you to the members of the Camden County Emerald Society Pipes and Drums with all my love and respect."

Drum Major Richard Desmond died on January 3, 2019, and never got the opportunity to call the Desmond's March at a gig. The first time that the Camden County Emerald Society Pipes and Drums performed Desmond's March at an official gig, was at the funeral for Drum Major Desmond on January 9, 2019
